CONDITIONS

- 10. Licensed material may only be used at the licensee's facilities located at: 6800 and 7000 Huntley Road, Columbus, Ohio 43229.
- A. The Radiation Safety Officer for this license is: Timothy Scott Keller.
 B. The Assistant Radiation Safety Officer for this license is: Shane Alan Willis.
- 12. Licensed material shall be used by, or under the supervision of: J. Louis Kovach, Timothy S. Keller, Gregory J. Glasco, Lucas S. Primel, Clinton B. Summers, Shane A. Willis, or *Abigail R. Vanbuskirk*.
- 13. All sealed sources that are used or obtained shall have been evaluated or approved under the provisions of OAC 3701:1-46-49, or by equivalent NRC or Agreement State regulation.
- 14. Sealed sources shall be tested for leakage and/or contamination according to OAC 3701:1-38-24.
- 15. The radium foil source listed in item 6.J. shall be tested for leakage and/or contamination every six months. The leak test analyses shall be performed by Troxler Electronic Laboratories or by an outside service provider specifically authorized to perform leak test analyses by the Director, the NRC, or an Agreement State.
- 16. Sealed sources containing licensed material shall not be opened or sources removed from source holders by the licensee.
- 17. The licensee shall conduct a physical inventory every six months to account for all sources and/or devices received and possessed under the license. Records of inventories shall be maintained for three years from the date of each inventory and shall include the quantities and kinds of radioactive material, manufacturer's name, and model numbers, location of the sources, and/or devices, and the date of the inventory.
- 18. Each portable device shall have a lock or outer locked container designed to prevent unauthorized or accidental removal of the sealed source from its shielded position. The device or its container must be locked when in transport, storage, or when not under the direct surveillance of an authorized user.
- 19. In lieu of using the conventional radiation caution colors (magenta or purple on yellow background) as provided in OAC 3701:1-38-18A(1), the licensee is hereby authorized to label detector cells, containing licensed material and used in gas chromatography devices, with conspicuously etched or stamped radiation caution symbols.
- 20. Maintenance, repair, cleaning, replacement, and disposal of foils contained in detector cells shall be performed only by the device manufacturer or other persons specifically authorized by the Director, the NRC or an Agreement State to perform such services.
- 21. Except otherwise specified in this license, the licensee shall have available and follow the instructions contained in the manufacturer's instruction manual for the chromatography devices.
- 22. In addition to the possession limits in item 8, the licensee shall further restrict the possession of licensed materials to quantities below the minimum limit specified in OAC 3701:1-40-17 for establishing decommissioning financial assurance.
- 23. Except as specifically provided otherwise in this license, the license shall conduct its program in accordance with the statements, representations, and procedures contained in the documents, including any enclosures. The Ohio Department of Health's regulations shall govern unless the statements, representations, and procedures in the licensee's application and correspondence are more restrictive than the regulations.
